



## Privacy Policy

**Last Updated:** December 27th, 2019.

Furvana LLP, (hereafter referred to as “Us”, “We”, or “Our”) as the owners and operators of <http://www.furvana.org/> (hereafter referred to as “The Site” or “The Website”) and the Furvana 2019 event (hereafter referred to as “The Event”) do hereby inform you of our policies regarding the collection, use, and disclosure of Personal Information collected by Furvana LLP.

We use your Personal Information only for purposes of identifying attending members of Furvana at The Event. By registering for The Event, you agree to the collection and use of this information in accordance with this policy.

### Information Collection

Upon registering as a member of The Event, we may ask you to provide us with Personal Information that can be used to contact or identify you. Personal Information may include, but is not limited to, your legal name, email address, mailing address, phone number, and date of birth.

### Log Data

Like many site operators, we collect information that your internet browser sends whenever you visit our site. This log data may include information such as your computer’s Internet Protocol (“IP”) address, browser type, browser version, the pages of our site that you visit, the time and date of your visit, and the time spent on those pages or other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor, and analyze this data.

### Communications

We may use your Personal Information to contact you regarding the status of your registration at The Event, or other information that is directly pertinent to your status as a member. We will not use your Personal Information for any promotions, newsletters, or other marketing purposes.

### Security

The security of your Personal Information is very important to us but no method of transmission over the internet, or any method of electronic storage, is 100% secure. While we strive to use and maintain reasonable means to protect your Personal Information, we cannot guarantee its absolute security.
